2. PURPOSE

The Civil Engineer will be responsible for inspecting and assessing project infrastructure across Papua New Guinea Government Funded Project sites. This role ensures that projects meet regulatory standards, quality benchmarks, and are executed in compliance with approved plans and budgets. The ideal candidate will have extensive experience in civil engineering, project management, and regulatory compliance.

3. ACCOUNTABILITIES

- Conduct thorough inspections of Government funded infrastructure projects, including roads, bridges, buildings, and other public works.
- Evaluate project compliance with approved engineering plans, specifications, and regulatory standards.
- Identify and document any deviations from project plans and standards, and recommend corrective actions.
- Ensure that construction materials and techniques meet established quality standards.
- Providing monthly briefs to MoC on infrastructure projects.

4. MAJOR DUTIES

- Identify and document any deviations from project plans and standards, and recommend corrective actions.
- Verify that projects adhere to relevant local, national, and international regulations and guidelines.
- Ensure environmental and safety standards are maintained throughout project execution.

- Prepare detailed inspection reports, highlighting findings, compliance issues, and recommended improvements.
- Maintain comprehensive records of inspections, including photographs, drawings, and correspondence.
- Liaise with government officials, contractors, and other stakeholders to communicate findings and facilitate improvements.
- Provide technical advice and support to the junior engineers and other relevant bodies.
- Participate in the development and implementation of best practices for project inspection and quality assurance.
- Stay updated with the latest advancements in civil engineering and construction technology.

5. NATURE AND SCOPE

A Civil Engineer manages construction projects, conducts site investigations, assesses risks, and ensures safe project completion. They collaborate with stakeholders, provide technical expertise, and oversee structure implementation.
